

Extended Day Program (EDP): Toddler - K0 100 N Street, South Boston, MA 02127 2025 - 2026

- Before School Program (drop off begins at 7:00 a.m.):
 - o Rolling drop off from 7:00 a.m. 8:15 a.m.
 - Drop off ends at 7:50 a.m. (no children will be permitted to enter after this time)
 - Students are to be dropped off at the 100 N Street door
 - Students spend the morning playing games, working on art projects, coloring, puzzles and playing with their peers
 - o Cost is \$15.00 / morning, flat rate
- After School Program (2:15 p.m. 5:30 p.m.):
 - Rolling pick up from 2:15 p.m. 5:30 p.m.
 - NOTE: There is a \$5.00 / minute late pick up charge assessed after 5:30 p.m.
 - Students are to be picked up at the 100 N Street door
 - This program serves as a true extension of the school day. It includes the following:
 - Extended center based play (dramatic play, blocks, reading, etc.)
 - Daily special activities (including: read alouds, sports and games, yoga, crafts, dance, music and instruments and more)
 - Gross motor play (outside or in the multipurpose space)
 - Time for snack (provided by school)
 - Cost is \$14.00 / hour
 - Via an electronic sign in / out system
 - A Pin # will be emailed the first week of school and families will have access the the Parent Portal
 - You will be billed monthly for Extended Day through FACTS
 - Example: September EDP charges will be posted to your accounts on October 5th and due by October 15th
 - If you withdraw from SBCA, no additional EDP charges will be incurred, and these fees are not subject to the Withdrawal Policy.

Extended Day Program Changes (K0 and Toddler only):

 For planning purposes and staffing, the Early Childhood program at South Boston Catholic Academy will be adopting new policies for the 2025 / 2026 School Year that apply to only students in the Toddler and K0 programs.

Sign Up:

- Prior to the start of school (no later than August 1st), families will sign up and select their days for the Extended Day program via Google Doc.
- Families will be guaranteed a space for the Extended Day program for their children if submitted prior to **August 1st**. We cannot promise availability after the deadline.
 - Please note, in order to keep within the Commonwealth of Massachusetts Compliance Laws, SBCA staffs the program accordingly and is required to pay our staff regardless if your child attends or not. Therefore, your account will be charged for absences on their scheduled days.
- Changes to your schedule must be submitted in writing to the Director (k.murphy@sbcatholicacademy.org)
 - Changes cannot be made on a weekly / as needed basis, as we need to ensure we are in compliance with the teacher / student ratio
 - Families are eligible to change their program choice throughout the school year if space is available
- You will be billed monthly for Extended Day through FACTS
 - Example: September EDP charges will be posted to your accounts on October 5th and due by October 15th
 - If you withdraw from SBCA, no additional EDP charges will be incurred, and these fees are not subject to the Withdrawal Policy.
